Privacy Policy

- 1. The Winnipeg Embroiderers' Guild (WEG) will collect only such personal information from its members as is necessary for the operation of the Guild and Guild activities, and to comply with the requirements of chapter membership in the Embroiderers' Association of Canada/Association canadienne de broderie (EAC/ACB).
- 2. The WEG will safeguard all personal information relating to Guild members, including addresses, telephone numbers, e-mail addresses and membership numbers.
- 3. The WEG will take all necessary steps to ensure that information it may have in its possession in relation to any WEG member is not used for any unauthorized purpose, either by another member of the WEG or any other person outside of the Guild.
- 4. Members of the WEG will fill out the attached Privacy Form when joining WEG that:
 - a. authorizes the collection and retention of personal information specified by the member by the WEG; and
 - b. confirms the member will not disclose the personal information of any other WEG member that may come into her/his possession.
- 5. Every member of the WEG has the right to withhold personal information from the Guild with the understanding that this may limit the ability of the WEG and EAC/ACB to communicate news and announcements to that member.
- 6. All WEG members will respect the confidentiality of personal information relating to another member of the Guild. Breach of Confidentiality will include providing the name and/or contact information of any member of the WEG to a person who is not a member of the Guild, without first obtaining the consent of the member concerned.
- 7. All personal information relating to any WEG member in the possession of the Guild will be destroyed not later than one year after the expiry of that member's membership in the WEG, with the exception of any material on or reference to that member in archived issues of the WEG newsletter and archival records of the WEG.
- 8. By submitting an application for any WEG activity, including courses and workshops, members consent to the collection and use of the information by the WEG as specified above.
